**SUBMITTAL REQUIREMENTS:**

1. Photographs of the existing residence and all yard areas.
2. Submit fully dimensioned Planting plans for entire site showing property lines, setback, and location of all existing and proposed improvements.
3. Show all plant material information, type, species, layout or arrangement for groundcover, shrubs, and trees.
4. Proposal to remove existing tree(s) must be submitted as part of any project scope for review and approval by the PVHA.

**Final inspection is required by the PVHA in addition to any inspections by the city. Call the PVHA at (310) 373-6721 for final inspection upon completion of construction.**
